## First Round Seat Allotment Schedule

Combined Option Entry and Seat Allotment Schedule for UGCET-2023 and UGNEET-2023

Admission to Medical, Dental, Engineering, Architecture, Veterinary, Farm Science courses i.e.,

[B.Sc. (Hons) Agriculture, Forestry, Sericulture, etc] B. Pharma and Pharm-D etc courses.

On 04-08-2023 Government has issued the revised seat matrix for admission to Engineering, Architecture courses. The same has been hosted on the KEA Website along with the seat matrix of other courses like Medical, Dental, Veterinary, Farm Science courses [i.e., B.Sc. (Hons) Agriculture, Forestry, Sericulture etc] and B. Pharma, Pharma-D courses issued by the Government. Fee structure issued by the Government for different courses is also displayed on the KEA Website.

Option entry for all these courses shall be held jointly. If a candidate is eligible for more than one discipline, then In the order of preference candidates have to enter options for all the above said disciplines to which they are eligible and interested. If a candidate is eligible for Medical / Dental and engineering discipline, then the candidate has to enter options for medical / dental and engineering and other courses in the same portal. Likewise, if a candidate is eligible for Medical / Dental, Engineering, Farm Science, Veterinary, Nursing etc disciplines, and then they have to enter the options in the same module in the order of preference for all such discipline to which they are interested. Detailed information along with video is hosted in the KEA Website on 04-08-2023 with regard to entry of options to different disciplines simultaneously.

Seat allotment is based on the seat matrix issued by the Government from time to time (01-08-2023, 04-08-2023) for different courses and by considering the merit and options entered by the candidates by following the roster system.

Ayurveda, Unani, Homoeopathy, Yoga & Naturopathy, B.Sc. (Nursing) seats would be included in the second round seat allotment upon receipt of the seat matrix from the Government.
